

PEMBROKE CITY COUNCIL MEETING MINUTES
March 9, 2015

The monthly meeting of the Pembroke City Council was held on Monday March 9, 2015 at 7:00 p.m. in the City Hall Council Chambers with the following members present: Mayor Pro-tem, Johnnie Miller. GEORGIA CITIES WEEK RESOLUTION A motion was made by Tiffany Walraven to adopt the resolution supporting Georgia Cities Week April 19-25, 2015. The theme for this year's event is "Destination Downtown". The motion was seconded by Diane Moore and agreed upon by all.

DEPARTMENT REPORTS Public Safety Director, Bill Collins reported that the City is in possession of the four vehicles that were purchased under the USDA Grant/Loan and a press release will be drafted soon. He also reported that an open house, showcasing Station #2, will be held on March 24th at 6:00 p.m. The playground equipment was sold on GovDeals and research is being conducted on new equipment.


COMMITTEE REPORTS None issued.
