 - Summer Beal and Frank Henderson presented the ongoing efforts to rebrand the Richmond Hill-Bryan County Chamber of Commerce to the Bryan County Chamber of Commerce in the coming year in order to offer the businnesses who fell under the scope of the North Bryan Chamber of Commerce (no longer in operation) access to the resources that being part of a Chamber of Commerce.



 Roll out is expected by October/November of 2024 with the rebrand of the Chamber of Commerce. Fernanda Camacho Hauser will provide support on in North Bryan and Summer Beal will travel between both ends of the county. Additionally, events and business after hours will occur on both ends of the county.

Presentation by Development Facilitators of the Old Baseball Field Project

Robert Reichert and Joshua Kight presented about the ongoing redevelopment plans for the Old Baseball Field by providing background on the RFQ sent out last year by the city of Pembroke as well as the role of the DDA vs the City in a project like this.

Land Transfers:

2 CHIP Housing project properties

- Tiffany Zeigler provided an update about this project.
- The two properties on Main Street and Ledford st will result in 7 additional CHIP houses as per the funding received for them.
- Old Baseball Field
- Dingle Building
 - Work to help preserve the existing building as well as the first steps towards the Elegibility for Nation Registry of Historic Places has been taken for potential funding sources.

• Old Business:

- Stateboro Market2Go
- O Whistle Stop Market
 - \$660 in Vendors fees has been deposited to the DDA Bank Account, and an additional \$400.37 will be transferred from the DDA Paypal to the DDA Bank Account for a total of \$1,060.37 in revenue from Vendor fees.
 - Fernanda Camacho Hauser requested to put some of that revenue towards a porta potty for the Whistle Stop Market. And for reusuable signage to be initially purchased for the Whistle Stop Market.
